**Permits shall specify places, dates and hours of the permitted activities and may impose terms and conditions appropriate to reduce the impact of the noise variance.**

No permit shall be granted for nighttime hours. Permits are valid for a specified five (5) hour period. Only one (1) permit shall be issued to a property in a thirty (30) day period.

A noise permit allows noise to be heard up to two hundred (200) feet from its source. If the noise can be heard further than two hundred (200) feet from the source, the noise permit is void. A Brentwood police officer or Code Enforcement Officer has the authority to revoke or impose restrictions on a noise permit if, in his or her judgment, the provisions of the City noise restrictions are being violated.

No permits will be issued from 8:00 pm to 8:00 am from Sunday through Friday and 10:00 pm on Saturday

Permits for residential properties shall cost ten dollars (\$10) and be available for inspection during the event.

Permits for non-residential property shall be posted so as to be visible to the public prior to and during the event; a fee of twenty-five dollars (\$25) shall accompany applications for such permits.

The Town Administrator or his/her designee is authorized to adopt and use such forms of applications and permits as may be reasonably required in the performance of his/her duties and enforcement of this section.

I understand that the issuance of this permit is conditional upon compliance with all regulations and ordinances of the Town of Brentwood. I agree to give full cooperation to the Town of Brentwood's Police Department in enforcing the noise ordinance, during the entire time for which this permit is issued. **I further understand that the issuance of a noise permit does not permit the noise level to create a nuisance but only permits the use of outdoor amplified sound and / or to exceed the normal noise limit level within the specified area.**
