RESOLUTION OF TOWN OF BRENTWOOD AUTHORIZING PARTICIPATION IN THE MARYLAND EMPLOYEES' PENSION SYSTEM

A RESOLUTION OF TOWN OF BRENTWOOD, A POLITICAL SUBDIVISION OF THE STATE OF MARYLAND, AUTHORIZING PARTICIPATION IN THE EMPLOYEES' PENSION SYSTEM OF THE MARYLAND STATE RETIREMENT AND PENSION SYSTEM ("MSRPS").

WHEREAS, the Town of Brentwood is a municipality of the State of Maryland, and is eligible to participate in the Employees' Pension System – Reformed Contributory Pension Benefit ("EPS") in accordance with the Annotated Code of Maryland, State Personnel and Pensions Article ("SPP"), § 31-102;

WHEREAS, the Town of Brentwood provides for compensation and benefits to its employees in exchange for their service to the citizens; and

WHEREAS, the Mayor and Council of the Town of Brentwood, has determined it would be in the best interests of the town and its citizens, and the eligible employees of the Town of Brentwood, to participate in the EPS;

WHEREAS, in accordance with SPP § 31-109(a)(1), a Resolution of the Mayor and Council of the Town of Brentwood is required to approve and effectuate participation of eligible employees in the EPS;

WHEREAS, the Town of Brentwood desires to participate in the EPS effective on July 1, 2021; and

WHEREAS, State law provides that the Town of Brentwood shall purchase 100% of the service credit for employment prior to July 1, 2021 for employees eligible for participation in the Employees' Pension System of the MSRPS who elect to participate before the effective date.


NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Town of Brentwood, hereby authorizes, approves, and agrees to implement participation in the Employees' Pension System of the MSRPS effective on July 1, 2021 at 12:00 a.m., pursuant to SPP § 31-109(a); and

BE IT FURTHER RESOLVED, by the _Mayor and Council of the Town of Brentwood, that in accordance with SPP §§ 23-204(a)(1)(vi) and 23-204(a)(3), eligible employees hired on or before June 30, 2021 and who remain employed by the town on July 1, 2021, shall have a one-time irrevocable election to join and participate in EPS effective July 1, 2021, by submitting a written application to the State Retirement Agency prior to the effective date of participation on July 1, 2021; and

INTRODUCED by the Mayor and Council of the Town of Brentwood, at a Meeting on June 10, 2021 at which meeting copies were available to the public for inspection.

ADOPTED by the Mayor and Council of the Town of Brentwood, at a Meeting on June 10 , 2021.






